## ***TOURNAMENT DETAILS***

1. Each Tournament shall be played according to the Rules of Rugby Fives as approved by The Rugby Fives Association, apart from the total number of points scored in each game/match. These shall vary as detailed below:-
  2. **SINGLES TOURNAMENT – SATURDAY 9.00AM ONWARDS**
    - Matches in all rounds shall be decided over 3 games, each game to 11.
  3. **DOUBLES TOURNAMENT – SUNDAY 9.00AM ONWARDS**
    - Each match shall be decided over 3 games, each game to 11.
  4. **SINGLES PLATE COMPETITION - SATURDAY 12.00PM ONWARDS**
    - This competition shall be open to all competitors eliminated in their first match played in either the first or second round of the Singles Tournament. A fresh draw shall be made for this competition.
    - This competition will start after the quarter-finals of the singles have finished.
    - Each match shall be decided over 1 game, 15-up, or as decided by the organiser.
    - A used ball from previous matches shall be used for all matches.
  5. **DOUBLES PLATE COMPETITION - SUNDAY 11.00AM ONWARDS**
    - This competition shall be open to all pairings eliminated in their first match played in the first round or quarter final of the Doubles Tournament. A fresh draw shall be made for this competition.
    - This competition will start after the quarter-finals of the doubles have finished.
    - Each match shall be decided over 1 game to 15, or as decided by the organiser.
    - A used ball from previous matches shall be used for all matches.

***IMPORTANT NOTICES TO COMPETITORS***

---

1. A referee shall be present throughout the Championships, and his decision in respect of any point in contention during any match shall be final.
2. On first arriving at the courts, all competitors should report to either the referee or organiser. If any unforeseen circumstances means a competitor would arrive after the scheduled start of his match, then all attempts should be made to inform the organiser as soon as possible.
3. It is essential that **ALL** matches commence at the time indicated in the programme.
4. The commencement time of a match indicated in this programme is the time that particular match should actually start, and **NOT** the time a competitor should report to the courts. Each competitor should therefore be changed and ready to commence play well before the scheduled start time of their match.
5. All players shall report to the referee 15 minutes before the scheduled start time of their match. Any player not ready to start their match at the stipulated time could be eliminated from the competition.
6. If, for any reason other than the late arrival of a competitor, a match cannot commence at the time indicated in the programme, the referee shall inform each competitor of the anticipated revised start time.
7. A warm-up time of five minutes shall be allowed for each match.
